April 21, 2022**

- 2. First Quarter Financial Review.** This is agenda item number 6. Finance Manager Christine McKinley will present the first quarter 2022 financial overview. We will also discuss the potential delay in receiving the second installation Cook County tax revenue due to the anticipated delay in sending out property tax bills.
- 3. Trustee Advocacy Elevator Speech.** This is agenda item number 7. As discussed in previous meetings, Trustees will work on completing a brief script to be used when talking with the community or potential Trustee candidates. At the April 21 Board meeting, we will ask all Trustees to complete the following sentences and/or identify other prompts.

- 4. Strategic Plan Update.** This is agenda item number 8. Our strategic planning process is on schedule. All the in-person community focus groups have been completed, and our survey closed with a total of 2,022 responses.

After the initiatives are approved, staff will complete the remainder of the plan, which is to identify the goals and objectives.

March 17, 2022

1. Call to Order

Notice of the time of the meeting and agenda having been posted on the library bulletin board and one other public place, forty-eight hours prior to the meeting as required by law, the meeting was called to order at 7:02 p.m. by Michael Duebner, President.

2. Roll Call

3. Public Comment

Ron Crowley-Koch, resident of Mount Prospect, holds a short story Book Club at the Main Library on Tuesdays every other month and asked to be included on the calendar program listing.

4. President’s Report

President Duebner asked the entire Board to complete their “elevator speech” to be discussed at the April 21 Regular Board meeting.

5. Consent Agenda

Motion was made by Trustee Haas and seconded by Trustee Fulk to establish the Consent Agenda as presented. Voice vote carried.

6. Presentation and Approval of Bid for Outdoor Electronic Sign

Director Reynders explained the Outdoor Electronic Sign project was originally scheduled for the fall of 2021, but due to a variety of reasons the project was moved to 2022. The public bid opening meeting was held on March 15, and the project was awarded to North Shore Sign.

Jeff Barmueller with North Shore Sign said that he is honored to work with the library and to be awarded the project. He explained the targeted completion date for the project is May and that North Shore will take care of the permits and details for the new outdoor sign.

Trustee Duebner thanked staff for their work on this project.

Motion was made by Trustee Haas and seconded by Trustee Bass to approve the bid for the Outdoor Electronic Sign for \$39,700 to North Shore Sign as presented. Roll Call Vote: AYES: Bass, Duebner, Fulk, Groenwald, Haas, O'Sullivan. NAYS: None. ABSENT: Gilligan. ABSTAIN: None. Motion carried.

7. Strategic Plan Update

Director Reynders reported the Strategic Planning process is going well and explained the various survey distribution methods including postcards to all households, e-newsletter, survey available on the website, and printed surveys at Main Library and South Branch. Additionally, 15% of random households received a printed survey mailing that included a self-addressed stamped envelope. In addition, targeted invitations have been sent out for the various Focus Groups sessions in March.

Trustees Bass, Duebner, Fulk, and O'Sullivan will attend the Strategic Plan Retreat on Monday, April 25 from 2-8 p.m.

8. Executive Director Report

Director Reynders reported that the State of the Village Chamber Annual Meeting will be held on Thursday, April 7 at 7:30 a.m. at the Old Orchard Country Club and asked if any Trustees wanted to attend. Trustee Haas expressed interest in attending this breakfast.

Director Reynders stated that the Statement of Economic Interest form needs to be completed by May 1.

Trustees reviewed the February 2022 Library Activity Report. Trustee O'Sullivan commented on the social media increase by over 200% in February.

March 2022

Youth Services

- 1) With funding from the Friends, we hosted our second “Woven Together: One Town, One Read, One Day” program featuring the beautiful picture book, *You Are Home* written and illustrated by Evan Turk. Each childcare center, preschool, and elementary school received free copies of the book and a curriculum guide. On March 8, the schools were invited to read the book, and we gave a school-wide presentation to Robert Frost (D59) in the morning. The day culminated with a virtual visit with the author.



- 2) In a partnership with the French Club at Prospect High School, we offered a French-themed storytime. Leading up to the program, we visited the high school and shared the books and songs. Library staff led the English portion of the program and the French Club read books and sang songs in French. Comments from program attendees were very positive, with one caregiver mentioning that she knew French when she was younger but had forgotten much of it. Seeing the students enjoy it so much inspired her to refresh her French and teach her grandchildren some.
- 3) We had 114 calls to the Dial-a-Story service in March, which is a monthly record. Content during March included stories in English and Spanish from Librivox.org as well as stories read by staff, jokes, and more.
- 4) St. Patrick’s Day was celebrated in a big way with leprechaun traps and a “Pot of Gold” scavenger hunt. Two hundred leprechaun kits were distributed with 50 being returned as traps. Twelve children captured a plastic leprechaun in their trap and received a free book as a prize. Kids completing the scavenger hunt won a stick-on green mustache (big hit!).

South Branch & Community Engagement

- 1) We added several new toys and games for in-house use, and they have been quite popular with our younger patrons. In fact, the only way a father convinced his little boy to leave was to promise him a trip to the store to buy the toys he was playing with.



- 2) We visited the Parent University at District 59's Early Learning Center and shared tips with parents for building early literacy skills. This was followed by a storytime presentation to families which featured the book, *Mother Goose Goes to India*. The group made egg shakers and had a dance party.
- 3) South Branch brought back in-person programs in March. Patrons expressed how nice it was to be back in person. Families especially enjoyed two sessions of "Minute to Win It," competing in a variety of fun challenges together.
- 4) We attended a very busy family literacy event at Robert Frost School in District 59 where they promoted library resources and registered families for library cards.



Research


- 1) "Picturing Women Inventors," a poster exhibition from the Smithsonian was on display at the Main Library in March.
- 2) We coordinated a total of 16 programs in March with 299 total attendees. A new program series, "Career Coach at the Library," featured multiple half-hour one-on-one sessions with a career coach online and will continue to be offered periodically in April and May.
- 3) We have been writing and posting a series focusing on information literacy skills to the "News from the Research Desk" blog. The March post, Sources for Statistics, followed previous posts on Health Information and Government Sources.

Fiction/AV/Teen

- 1) March was a strong month for teen programming. The highlight was an escape room program inspired by Teen Think Tank attendees, which ran for 10 sessions across three days.
- 2) Teen outreach was also active; in addition to collaborating with Youth Services and the Prospect High School French Club for a French-themed storytime, we held a well-attended Tinker Day of activities at Rolling Meadows High School.
- 3) A very popular virtual author visit with Madeline Miller was held, with options to participate either virtually or in-person.



Registration

- 1) Data from over 22,000 Mount Prospect patron cards was sent to Unique, an address service that works with the USPS to verify addresses of residents.

Verifying residency this way will cut down on patrons having to manually update their library cards and help keep Horizon more accurate. We've dubbed this "auto-renewal for patrons."

- 2) We began taking reservations for public meeting room use in March (meetings to begin in May), and the community is very happy to have this service restored.

Circulation

- 1) Circulation numbers have been strong in 2022, and March was a particularly strong month for overall circulation. Total circulation for the month was 87,435 – the highest March since 2017. Automatic renewals and a continued increase in media downloads are significant factors in our higher circulation numbers, though physical checkouts are strong as well.
- 2) We have put together some guidelines and resources to aid in the coordination and smooth operation of outreach events that involve library card registration and/or onsite checkouts. The new process is close to being ready to put in action, and we are excited to start attending outreach events again.

Building & Security


- 1) After the approval of the bid for the new outdoor electronic sign, we finalized the drawings, pulled permits, and placed the order. We expect installation in late May.
- 2) Last year we went out to bid for our garage ceiling to be painted. We had expected to have the work done in October 2021, but due to weather conditions it was delayed until March 2022. The contractor, D.E.S. Painting, started on March 23 and has completed the project.
- 3) We converted telephone landlines for the emergency phones in the elevators and the security system to cellular lines. The elevator lines were completed in March, and the security lines will be completed in April.

Collection & Bibliographic Services

- 1) We initiated a service from a new vendor, Rivistas, to consolidate magazine renewals for about 125 magazine titles, which saves a significant amount of staff time required to manage individual subscriptions. Not all of our titles will be managed by Rivistas, though, because we try to only have them manage subscriptions where there is a good price advantage to add the service (taking overall value into account – time-savings vs. price paid). When each title comes up for renewal, we simply click “Renew” or “Cancel” on our customer portal dashboard, and Rivistas takes care of the rest. We pay a single annual fee for a year’s worth of subscription management, so the MPPL business office will see well over 100 fewer renewal invoices to process on an annual basis. These time savings will increase over time as we add more titles to the service.

Communications & Creative Services

- 1) March was the big push for promoting the strategic planning survey, which included the website, postcard, app, e-newsletter, print, and social media. We achieved our survey collection goal within the first 10 days and our stretch goal a few days after that. By the close of the survey, we fittingly received 2,022 responses.
- 2) We worked with Youth Services to order new signage for and rebrand the backgrounds for our “You are Home” StoryWalk. The new signage is heavy, durable, made for the outdoors, and will be able to be reused for future StoryWalks.



Human Resources & Learning

- 1) Number of terminations and new hires: None
- 2) Staff anniversaries: Shang Liu (CBS) – 20 years
- 3) We went over seven weeks without any active job openings, which provided us with additional time to configure and implement the Applicant Tracking System. A significant amount of time was spent on training HR staff in preparation of the new system going “live” and automating our recruitment process.
- 4) To meet the mental health needs of the staff as we come out of the pandemic, we are providing access to Calm Premium content to all staff. In the first month that it was available, over 40% of the staff took advantage of the subscription to Calm. Over 75% of these staff are using the content provided regularly.
- 5) Four staff attended the three-session workshop, *How to Build and Antiracist Library Culture* as part of our DEI staff training focus. These DEI Committee members listened to speakers who presented information on examining programs and policies with an antiracist lens, and they participated in an equity-focused group project that could benefit the library.
- 6) Eight staff attended the Public Library Association Annual Conference, seven in-person in Portland, OR and one virtually. All who attended are preparing to share the information and ideas they took away from the conference to all staff in May.


- 1) The Friends next book sale is scheduled for May 14 and 15, and it will take place in Meeting Room A, the lower-level Friends space, and in the parking garage.




Overall Circulation YTD




Overall Circulation 2022 by Month




eMedia Circulation YTD




eMedia Circulation 2022 by Month





Door Count 2022 by Month - Main




Door Count 2022 by Month - South Branch




Main Study Room 2022 by Month



Wireless Unique Users




Entrance Used at Main


Program Attendance 2022 by Month
